Self-evaluation:

- 1. The Board Chair receives notification from the VPAA's office when a student has committed more than one violation or when an incident is egregious. All first time offenses are kept on file in the Office, but not reviewed by the Chair. However this year the Chair decided to review the first time offenses to get a better sense of what types of violations were occurring overall. This could help guide prevention efforts. There were approximately: 11 reported cases of plagiarism, such as cutting and pasting from internet and/or without proper citation; 2 cheating on exam incidents; 4 cases of students stealing the work of another student; a cluster of Chegg incidents; a case of deception; and a couple of cases of students using unauthorized materials.
- 2. The Board will continue to remind professors to state academic integrity policies and work expectations clearly in all syllabi and assignments. The professors will also be reminded to teach students what it means and looks like to paraphrase, quote, cite and otherwise give credit where credit is due and work with integrity. Professors may find it worthwhile to urge/require some students to use the Writing Center as warranted. Professors will be reminded to hold students accountable for their actions by reporting incidents to the VPAA using Maxient.
- 3. The reporting form has been found to help organize and communicate incidents.
- 4. The use of online services such as Chegg is a rising concern. There is not much professors can do more than state policies in their syllabus that forbid use of these specific types of services, and continue to be vigilant. Chegg, and similar sites, will produce reports when suspected breach of copyright or other laws/policies are possibly violated, but the process is laborious for the professor.
