PRIMARY PURPOSE:

Work with Director of Partnerships and Placements to ensure the implementation of all policies and procedures related to partnerships and placements between the Feinstein School of Education and Human Development (FSEHD) programs, PK-12 Schools and community agencies and organizations.

DESCRIPTION OF DUTIES AND RESPONSIBILITES:

Essential Job Functions:

- In collaboration with the Director of Partnerships and Placements, review, maintain and monitor school districts' requirements for observation, practicum and student teaching placements.
- Modify and/or establish placement procedures in accordance with district policies.
- In collaboration with Director of Partnerships and Placements coordinate and maintain the process for securing observation, practicum and student teaching placements. Manage the placement / matching of teacher candidates with cooperating teachers.
- Maintain teacher candidate, cooperating teacher and clinical placements data bases.
- Consult with Associate Deans of Teacher Education to ensure teacher candidates meet all
 requirements for student teaching. Review and approve student teaching online applications and
 permit forms.
- In collaboration with Program Coordinators, coordinate and maintain communication with teacher candidates regarding placement information, student teaching information, and student teaching certificates.
- Maintain communication with department chairs, program coordinators and faculty to identify
 appropriate practicum sites, college supervisors and cooperating teachers and ensure all practicum
 and student teaching requirements for are met.
- Plan and execute student teaching orientation meetings each semester in collaboration with Director of Partnerships and Placements and Associate Deans of Teacher Education.
- Update Student Teaching Handbook and maintain Office of Partnerships and Placements web presence in consultation with the Director of Partnerships and Placements.
- Facilitate and coordinate teacher candidates' criminal background checks as per district regulations.
- Process clinical instructor, cooperating teacher payments and mileage reimbursements.

Occasional Job Functions:

• May supervise student workers.

 Perform other duties and responsibilities as assigned by the Director of Partnerships and Placements.

Minimum of five years' experience in coordinating practicum and student teaching placements, or similar experience placing undergraduate or graduate students in experiential learning opportunities.
