## **PRIMARY PURPOSE:**

Responsible for the direction of college-wide programs of athletic/recreation offerings. Manage marketing, public relations, resources development, fund raising and other external affairs and aspects of athletics/recreation programs in conjunction with both athletic and college expectations, goals and strategic plan. Act as Executive Director of the Anchor Fund.

### **DESCRIPTION OF DUTIES AND RESPONSIBILITIES:**

# **Essential Job Functions:**

- Plan, develop, and administer the intercollegiate athletic programs consistent with conference
  and NCAA affiliation guidelines; the intramurals and recreation programs that are integrated into
  the academic, student life, and advancement areas of the campus community, and which are
  consistent with the value and philosophy of Rhode Island College.
- Develop, recommend, implement, and maintain intercollegiate athletic, intramurals, and recreation policies and procedures.
- Oversee administrative scheduling and contracts for all athletic events.
- Manage the selection, supervision, and evaluation of all full and part-time athletic, intramurals and recreation staff.
- Prepare, manage, and account for the department's personnel and budget.
- Represent the college at appropriate conferences, NCAA, and other professional meetings as approved.
- Serve on committees and prepare appropriate reports concerning athletics, intramurals, and recreation.
- Prepare and submit to the college administration the budget(s) for the Department.
- Act as Executive Director of the Anchor Fund.

  ability to generate and maintain good interpersonal relationships with professional colleagues,
  the College community, and a diverse set of publics.
- Ability for creative and innovative development of successful methods for distribution of sports
  information and the ability to work effectively with college students and other staff in a
  supervisory capacity; ability to interact effectively with all campus constituencies; ability to
  interpret intercollegiate athletics within the mission and goals of Rhode Island College and the
  NCAA III classification.
- Ability to travel as needed to athletic and fundraising events.

- Teaching experience in Physical Education and related areas with experience as Head Coach or Assistant Coach.
